## The following will be discussed with possible action as necessary:

- 1. Call the Bexar County Emergency Services District No. 8 Meeting to Order and establish a quorum. Commissioner Hune called the Bexar County Emergency Services District No. 8 meeting to order at 6:31 P.M. and established a quorum.
- 2. Pledge of Allegiance. Pledge of Allegiance was recited.
- 3. Citizens to be heard. (Individuals have 3 minutes) There were no citizens signed up to speak.
- 4. Approval of the minutes from the meeting held on June 14, 2022. Commissioner Burke made a motion to accept the minutes as written. Commissioner Voss seconded. The motion carried by a vote 3-0
- 5. Discussion and possible action on adjusting the wages and compensation package for full time employees. *Commissioner Voss made a motion to approve the wages and compensation package as presented. Commissioner Burke seconded. The motion carried 3-0*
- 6. Discussion and possible action to retain AG/CM for Project Management Support Services for the planning and construction of Station 3. Commissioner Burke made a motion to retain AG/CM project management support services for the planning and construction of Station 3. Commissioner Voss seconded. The motion carried 3-0
- 7. Discussion of the Mid-Year Financial Status of the District. Year to Date *Financial reports reviewed for the District.*
- 8. Chief's report. Chief Reddout provided the Board a review of the number of calls for service, and a review of overall response times. Noteworthy activity this month included assist with anaphylactic episode, brush fire, and 4 natural gas line ruptures. Additionally, the department was a cooling center, conducted training courses.
- 9. Review the meeting plan, canvas the Board for items to be consider at the next meeting scheduled for August 9, 2022. *Item of note for next meeting will be review and discussion of the FY2023 budget.*
- 10. Adjourn. With no further business before the Board the meeting was adjourned at 7:25 P.M.
