Meeting Minutes**



The Bexar County Emergency Services District No. 8 will conduct a meeting at the Emergency Services District No. 8 Fire Station located at 20825 Babcock Rd, San Antonio, Texas 78255 on November 13, 2025, beginning at 6:30 P.M.

This month's noteworthy activity included - Had 4 cardiac arrest in 36 hours; one on hospice, one obvious doa, one potential overdose, one gi bleed conscious on arrival; Vehicle rollover in CoGF; MVC after evading police, multiple patients, two P1 one P2 one in custody; Grass / brush fire by the Vue apartments started by welder; Grass / Brush Power lines easement Kyle Seale.
